AREAS OF LAW

Employment

Bianca's employment law experience includes:

- Dealing with claims across the spectrum of employment law, including unfair dismissal, disability discrimination, sex discrimination and harassment.
 - Drafting grounds of compliant and grounds of resistance in the ET.
 - Drafting the witness statements in a five-day ET matter.
 - Drafting a number of opinions on a variety of subjects, for example, on whether certain consultancy agreements fell foul of section 27A of the Employment Rights Act.
 - Appearing at preliminary hearings in order to argue preliminary issues, for example, in respect of amendments and jurisdiction disputes.
 - Attending case management hearings in the ET.
 - Considering restrictive covenants and assessing whether they were enforceable.

Commercial

Bianca has been involved in a range of commercial law matters, including:

- A High Court appeal hearing relating to the principle of attribution.
- Various shareholder disputes (for minority and majority shareholders).
- Appearing in winding-up lists, bankruptcy petitions and County Court matters.
- Drafting particulars of claim in a civil fraud matter.
- Drafting a defence and counterclaim in a contractual dispute.
- Drafting a number of opinions on a variety of subjects, for example on whether proceedings could be instituted against a director for damages as a result of the Company having been dissolved and struck off the Companies House register.
- As an advocate in South Africa Bianca's practice principally involved commercial law, acting for both financial institutions and private individuals. Her work ranged from drafting pleadings and opinions to presenting arguments before Judges and arbitrators.

Bianca has a developing interest in sports law, and during pupillage has gained experience in:

- A High Court breach of contract claim brought by a football agent against a premier league player.
- Internal appeal processes and enquiries of governing bodies of certain sports.
